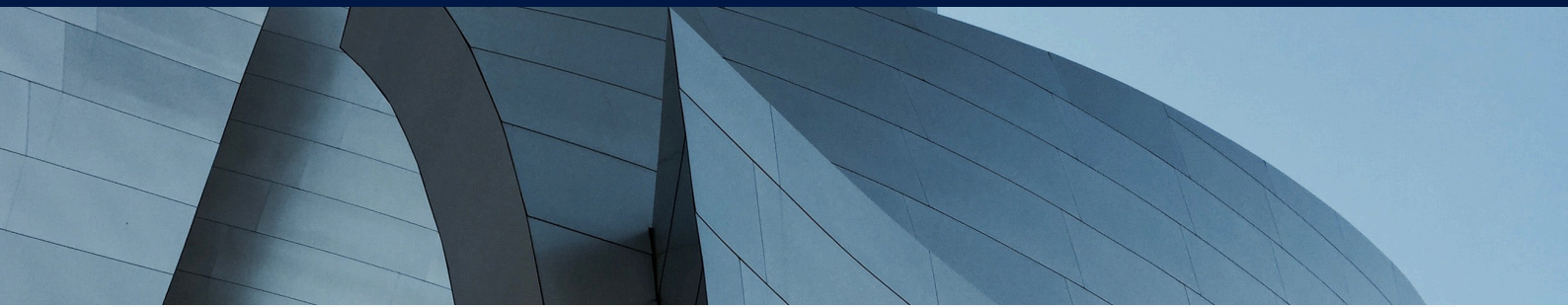

The Nordic market also provides a stable and attractive environment for institutional investors, supported by a mature regulatory framework and strong political backing for fossil-free energy.

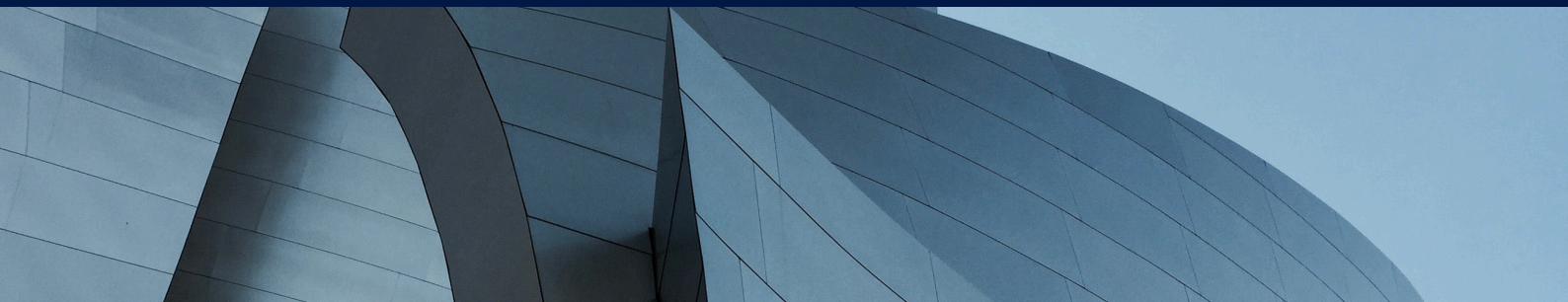
