SFDR 2.0: From Transparency to Categories - What's changing, what's unclear, and how to prepare



In its SFDR 2.0 proposal (Nov 2025), the European Commission set out to deliver simpler and more usable information for investors and make products easier to understand and compare – while simplifying and reducing sustainability-related administrative and disclosure requirements. The Commission explicitly points to disclosures that are too long and complex and SFDR's use as a "de facto labelling system", which increases the risk of greenwashing and mis-selling.

Now the tabled proposal raises in the current form as many questions as it solves, in particular for alternative investors.

The webinar will focus on the main requirements, impacts for the different categories and what a transition playbook (from SFDR 1.0 to 2.0) should consider.


